A. Termination

B. Reporting, Turnaround and Quality Assurance:

C. Confidentiality:

- ☐ PIXEL DIAGNOSTICS AND IMAGING shall not during the continuance of her/his agreement with the Company or at any time thereafter, divulge or disclose either directly or indirectly to any person, firm or company or use for herself/himself or others any knowledge, information or document which may have been imparted to him in confidence or is otherwise acquired by him during the course of or incidental to his/her agreement with the Company concerning the business, property, contracts, clients, methods or working, process, trade secrets, know-how, transactions, affairs or activities of the Company or its subsidiaries and affiliates.

D. Appointment Process:
